Polyphenols, such as resveratrol, possess powerful antioxidant properties that help fight cell-damaging free-radicals in the body which can contribute to oxidative stress, and in turn may contribute to the premature aging of cells.\* Each softgel contains more resveratrol than a typical bottle of red wine.
